

JERSEY SPORT FUNDING

Terms and Conditions 2026

For sport organisations (associations, clubs, businesses or groups) who have been awarded funding for projects or programmes in 2026.

1. Organisations who are successful in their funding application ('award') are required to meet all conditions of award before payment will be released. Support is provided by Jersey Sport to meet and exceed requirements.
2. Jersey Sport will conduct spot checks, at its discretion, and reserves the right to audit the organisation and the information provided as part of the award process. Proof of spends must be retained by the organisation for up to twelve months from the completion of the project or programme. When requested, organisations will have a maximum of two weeks to present relevant information.
3. Jersey Sport reserves the right to cancel an award, require repayment and/or exclude the applicant and/or organisation from access to future funding opportunities if we find that any information provided in the application, report, spot checks or audits was misleading, inaccurate or fraudulent.
4. The awarded funding is provided on the basis that the costs it is meeting have not and will not be secured from other sources. If all or part of the funding is sourced elsewhere, unless this has been stated in the application, you must at once disclose it to Jersey Sport and in that case the awarded amount may be reduced to a lesser amount, or to zero.
5. If your organisation is unable to use the awarded funding for the purposes originally specified and within the timescales stated and agreed to, Jersey Sport must be informed immediately. If you require any support or changes to be considered and approved, please email: funding@jerseysport.je.

6. The agreement or rejection of any changes to the project or programme purpose will only be valid once confirmed in writing by Jersey Sport. Any changes should not be implemented until this has been received.
7. Any additional or special conditions of award notified in writing by Jersey Sport via our online management system, by email or by letter, also form part of these Terms and Conditions under which the awarded funding is paid.
8. Where awarded funding is disseminated by one organisation to another (for example during collaborative projects or projects involving multiple stakeholders), the applicant must ensure all other organisations meet the requirements of the award and use the monies solely for the purposes set-out in the relevant fund criteria.
9. If your organisation ceases to exist, becomes insolvent, goes into administration, receivership or liquidation, Jersey Sport should be contacted at the earliest opportunity.
10. If within the lifetime of the awarded funding your organisation undergoes a merger, consideration will be given to the award being transferred, subject to the merged organisation being eligible to receive funding. This is only at the sole discretion of Jersey Sport.
11. Jersey Sport reserve the right to visit your organisation to see and discuss the work supported by the award. Jersey Sport also retain the right to require the organisation's attendance at a meeting at a mutually agreed date, time, and venue.
12. Jersey Sport may use information provided by your organisation to monitor or publicise the award and/or evaluate our funding opportunities.

13. Information regarding your organisation and the award received may be published by Jersey Sport on its website and social media channels. Jersey Sport reserves the right to use the information in any other printed or digital information it produces.
14. Your organisation will acknowledge any awarded funding in its financial accounts as '*Restricted Funding*' and the source of the award as '*Jersey Sport*'. The awarded funding should also be specially acknowledged in your organisation's annual accounts/reporting using one of the following forms of wording:
 - "Supported by Jersey Sport".
 - "Funded with the support of Jersey Sport".
 - "Jersey Sport".
15. Jersey Sport requires acknowledgement of the award in the publication of all core materials that your sport organisation produces, in print and digital, that refer to the project for which your organisation has received funding. Jersey Sport require your organisation to notify them in advance of any intention to publicise the subject of the funding and to keep Jersey Sport informed of any media coverage relating to it. Organisations should use either of the following wording in any publications referring to their funded project:
 - "Supported by Jersey Sport".
 - "Funded with the support of Jersey Sport".If you have any queries or would like guidance in promoting the award and the work of your organisation, please contact marketing@jerseysport.je.
16. Jersey Sport holds the contact details of your organisation and your application on our database for the purposes of the administration of the awarded funding. All personal information we collect from you will be recorded, used and protected by us in accordance with the Data Protection (Jersey) Law 2018 and our Privacy Policy (available at www.jerseysport.je). We may

supplement the information that you provide with other information that we obtain from our dealings with you.

17. You have the right, at any time, to ask us to delete or update the information we have about you. You can do this by calling: 01534 757700 or emailing us at: info@jerseysport.je

18. Appeals:

- a. If an applicant wishes to appeal a decision, they need to submit a Letter of Appeal to the Jersey Sport CEO within 15 working days of receipt of the decision (david.kennedy@jerseysport.je)
- b. The Letter of Appeal needs to contain the nature of the appeal and refer to the reasons why the application was turned down, or not fully funded, and provide extra information and evidence as to the basis of the appeal.
- c. On receipt of this Letter of Appeal, the CEO will inform Jersey Sport's voluntary Charitable Funding Committee that an appeal has been received, providing the Letter of Appeal, application and original decision comments.
- d. The CEO will provide a written response within 15 working days of the received date of the Letter of Appeal.
- e. The decision of the Jersey Sport CEO will be final and there will be no further appeal.

19. Applicants should inform Jersey Sport if they receive any appeal related to any awarded funding, or any other pertinent information not captured in the detail of this Terms and Conditions.
